



## FAQ: SELF-PACED ONLINE MODULES

### Q 1: What are Self-Paced Online Modules?

Ans: Four self-paced online modules [SET A, SET B, SET C and SET D] encompassing different fields have been introduced in the New Scheme of Education and Training.

As the name suggests, Self-Paced Online Module is a course which a student can learn and qualify at his/her own pace after registering in Final Course.

### Q 2: What are the subjects in Self-Paced Online Modules?

Ans: Self-Paced Online Modules, comprising the Following Papers and students have to undergo prescribed hours of learning through New Portal ICAI digital Learning Campus at <https://lms.icai.org/login> as under:

### Q 3: What is the registration process for Self-Paced Online Modules?

Ans: At the time of registration in Final Course, students would also be registering for Self-Paced Online Modules. The Final Course registration form will have the option for selecting

the subjects under Self-Paced Online Modules SET C and SET D. No separate fee is payable for registration of Self-Paced Online Modules.

**Q 4: Whether papers in Self-Paced Online Modules are mandatory?**

Ans: SET A: Corporate and Economic Laws and SET B: Strategic Cost and Performance Management are mandatory papers under Self-Paced Online Modules. SET C and SET D are comprising of 10 subjects and 4 subjects respectively. A student, as per his/her interest, have to opt any one of the subjects from each SET C and SET D.

**Q 5: What will be the manner of learning of Self-Paced Online Modules?**

Ans: The study materials for the Self-Paced Online Modules for all subjects have been uploaded in the BoS Knowledge Portal. Physical Study Material of SET A and SET B, physical Study Material are also be made available. Besides e-Books, video lectures of experts in the relevant subject area, will be made available to the students.

The Institute has developed New Portal ICAI digital Learning Campus at <https://lms.icaai.org/login> whereat Students can undergo prescribed learning hours for each Self-Paced Online Module for being eligible to appear in the respective examination conducted by Examination Department.

**Q 6: What will be the level of understanding required for SET A, SET B, SET C and SET D?**

Ans: Expert knowledge is expected in SET A and SET B. Working knowledge is expected in SET C and SET D.

**Q 7: What is the requirement for qualifying Self-Paced Online Modules?**

Ans: A student is declared to have qualified a Self-Paced Online Module if he/she secures a minimum of 50% marks in that module. There will be no restriction on the number of attempts for each module.

**Q 8: Is there any negative marking in Self-Paced Online Modules?**

Ans. There is no negative marking in examination of Self-Paced Online Modules.

**Q 9: Will the marks secured in Self-Paced Online Modules be aggregated with the marks obtained in Final Examination for passing the Final Examination?**

Ans: The marks secured in Self-Paced Online Modules will not be aggregated with the marks obtained in the Final Examination.

## Q 10. SELF PACED ONLINE MODULES (SPOM)

The Exam department of ICAI has launched Self-paced Module Test (SPMT) Portal <https://splt.icai.org> for candidates who have completed prescribed learning hours for respective Self-Paced Online **Module A: Corporate and Economic Laws** and **Module B: Strategic Cost & Performance Management**. Details of eligibility of such candidates are as below:

- A. The students who were admitted to the Final Examination till November, 2023 are exempt from appearing in Self-Paced Online Module Tests Set C and Set D. However, it is mandatory for them to qualify Set A and Set B as per below eligibility criteria, before applying for membership-

Sr. No.	Criteria	Module Tests to Be Qualified
1	Appeared in Final Exam till November 2023 but could not pass either of the groups	SET A AND SET B
2	Passed group second till November 2023 but could not pass group first	SET A only
3	Passed group first till November 2023 but could not pass group second	SET B only
4	Exemption in Paper 5 till November 2023 but could not pass group first or Both Groups	SET A only
5	Exemption in Paper 4 till November 2023 but could not pass group second or Both Groups	SET B only
6	Exemption in Paper 4 and Paper 5 till November 2023 but could not pass either of the groups	All Modules Exempt

- B. Students, other than those who are covered under (A) above, who were admitted to the Final Examination of May, 2024 or those who have passed both groups of Intermediate examination under old scheme and completed 2.5 years of Practical Training till 31<sup>st</sup> October 2024 including excess leaves, if any, as well as Advanced ICITSS are exempt from appearing in Self-Paced Online Module Tests Set C and Set D. However, it is mandatory for such students to qualify Set A and Set B before applying for membership.

Intermediate students who had cleared either of the groups upto 0 November 2023 or before and cleared the remaining Group under Unit Scheme in May 2024.

**Or**

**Those who cleared both groups of Intermediate exams in May 2024, are required to undergo and pass Self-Paced Online Modules on/before 10th October, 2024 to become eligible for Final Exam to be held in November 2024.**

- **Web Browser:**

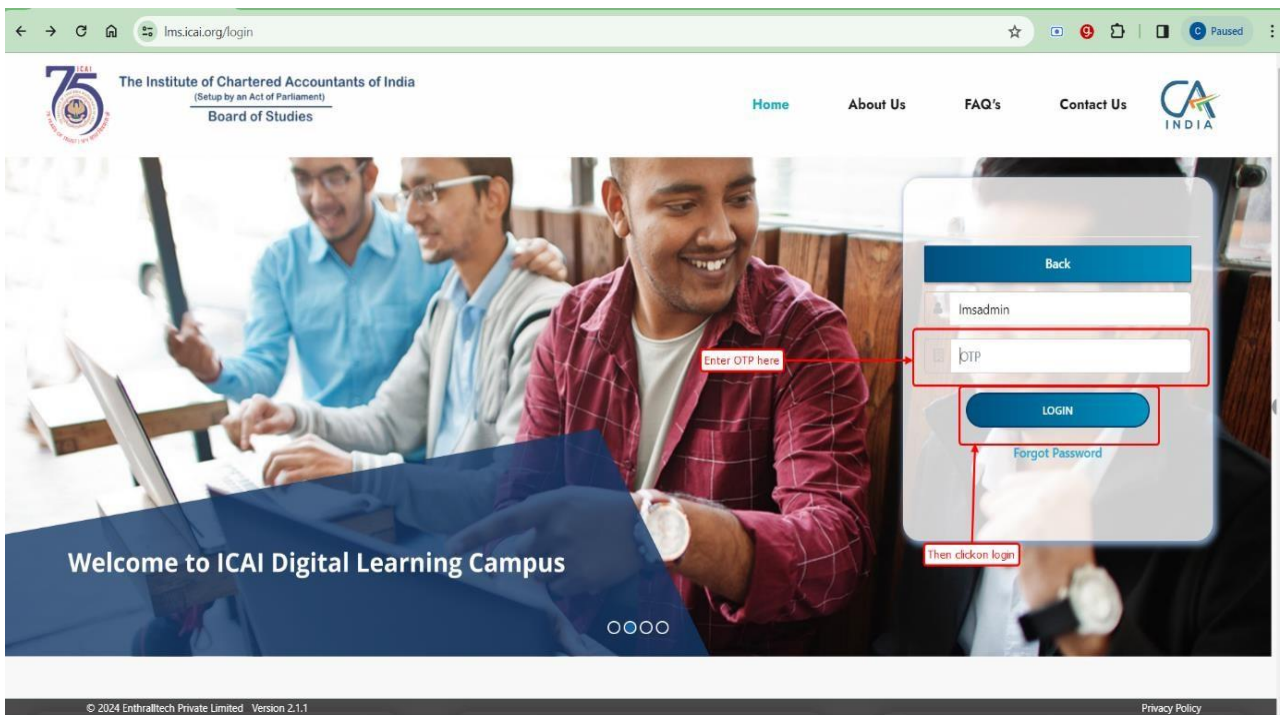
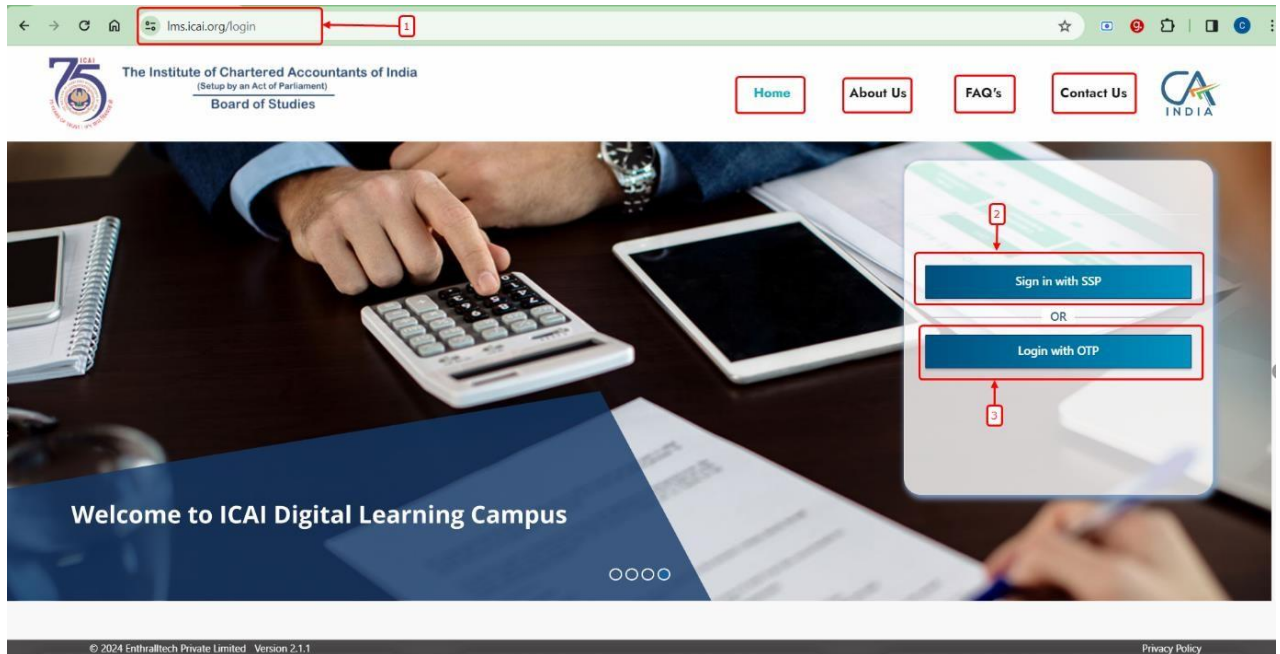
The system should be compatible with modern web browsers such as Google Chrome, Mozilla Firefox, Safari, and Microsoft Edge.

**Q 18: Where to Login to access the Self-Paced Online Module SET-A and SET-B to undergo requisite Hours ?**

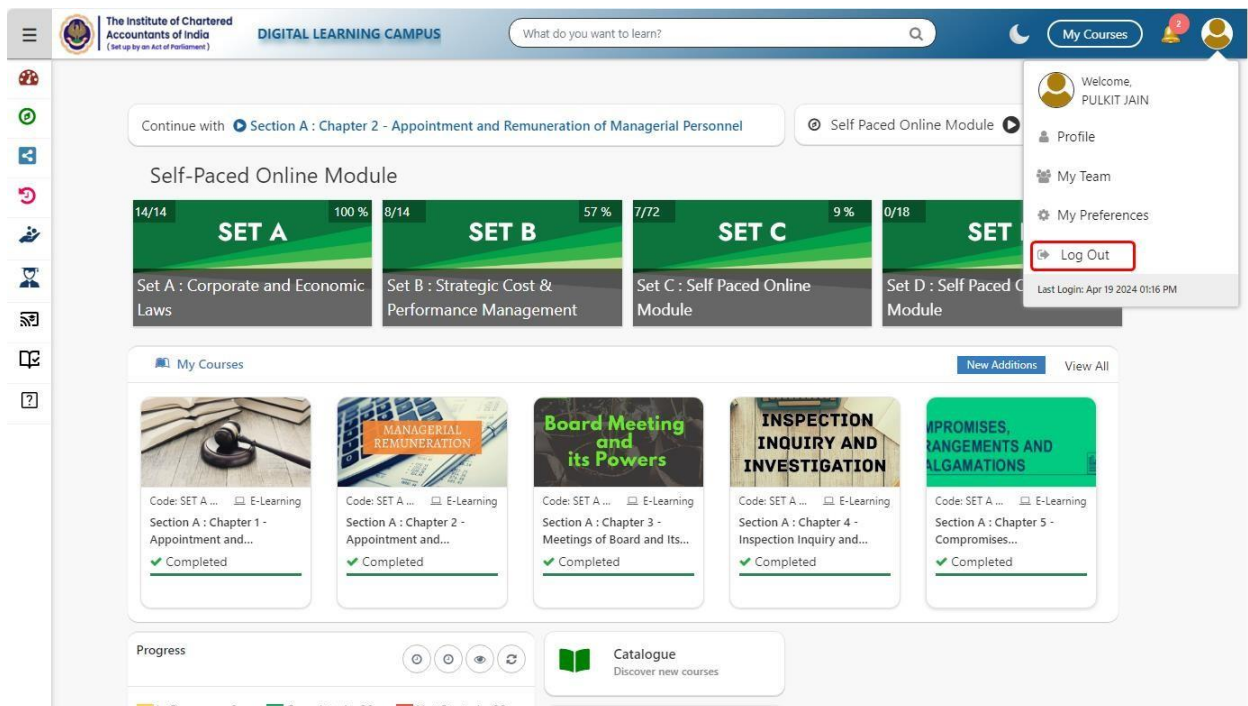
Ans. The student has to visit URL: <https://lms.icai.org/login>



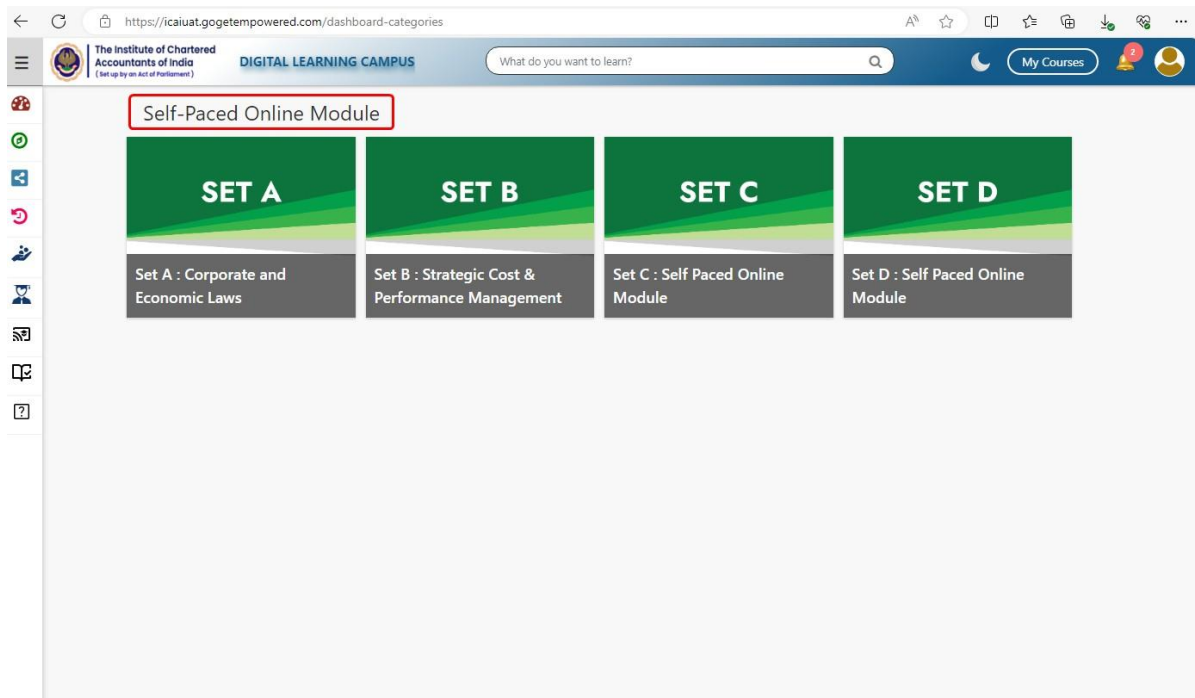
1. **URL:** The student will open the URL of their web browser as per the above mentioned URL.
2. **Sign in with SSP:** The student will use their SRN no. to login to the LMS

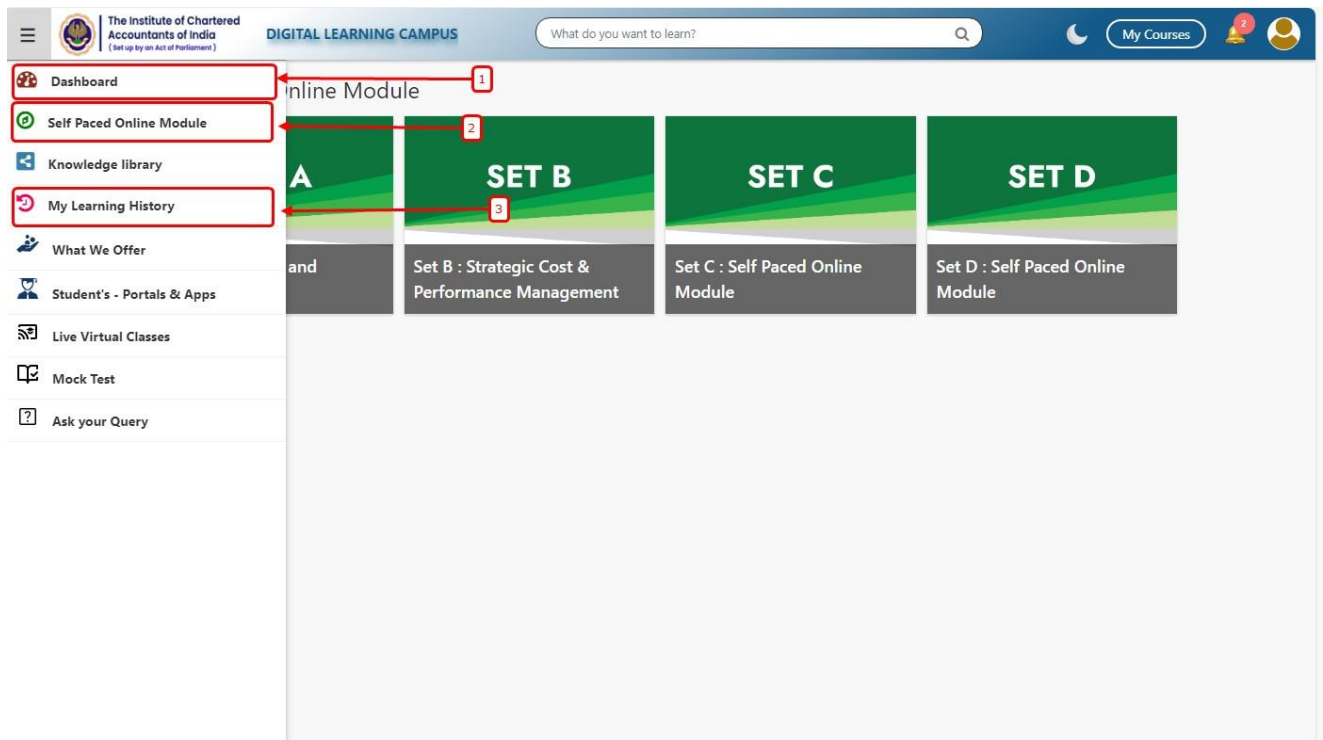
**Logout:** To logout of the system, the Student has to open their profile and click on the logout button. Refer below screenshot for the same.



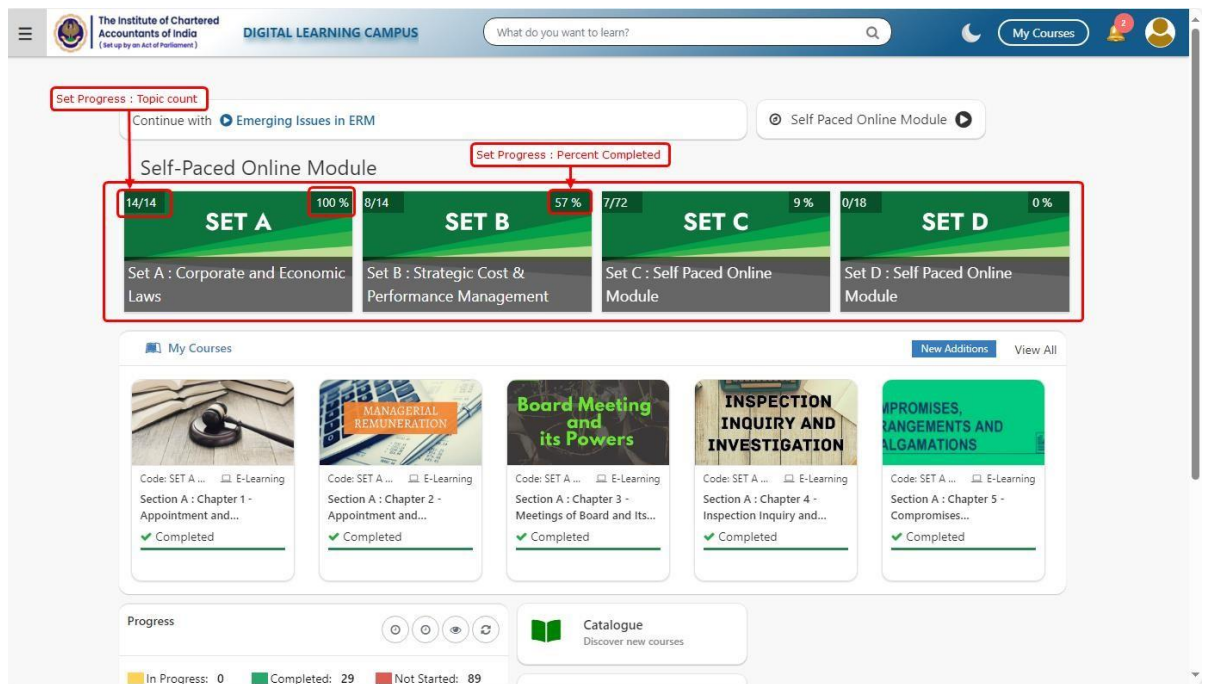

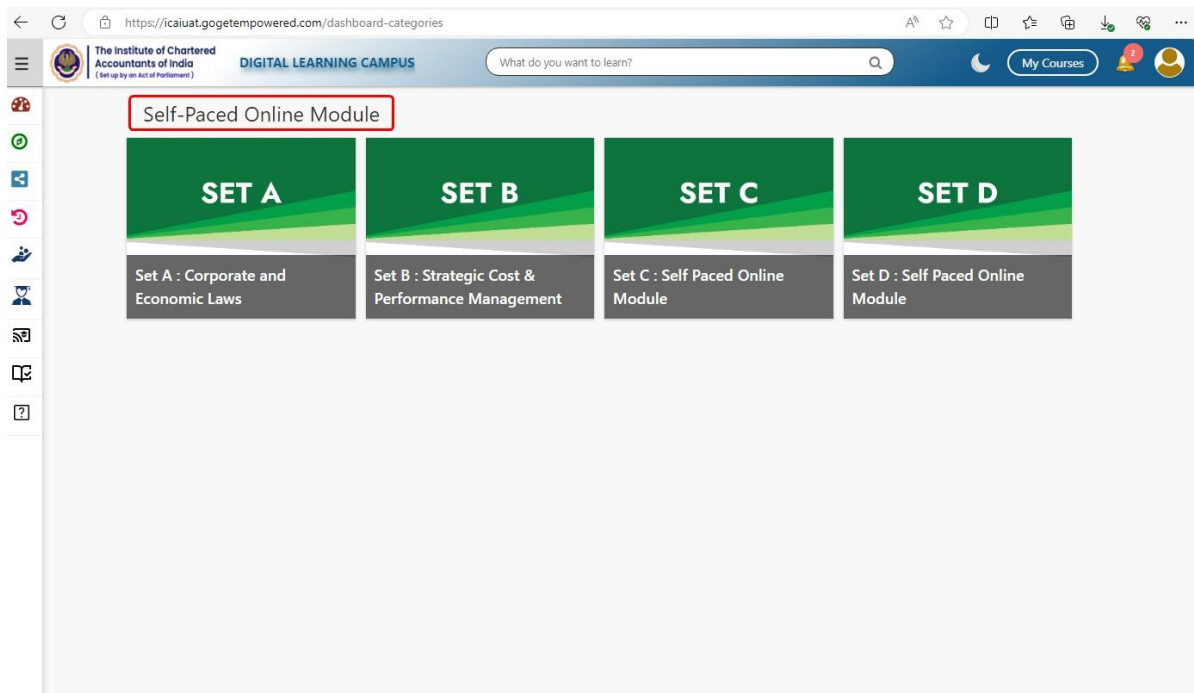
**Menu Bar:** The Student will be able to navigate through all the tabs available on the LMS as follows:
